#### Membership Privileges:

- 1. Members pay user fees: \$2 for 9 holes and \$4 for 18 holes. Golf Carts are optional except during Masters Week. Check in is mandatory for all rounds.
- 2. Cart fees are \$13 for 9 holes and \$21 for 18 holes. Golf Carts are charged per seat with maximum of two golfers per cart. All drivers are required to be 16 years of age and must possess a valid state driver's license.
- 3. Range ball fees are \$5 for one token.
- 4. Members may make tee time reservations 7 days in advance (Non-members may make tee time reservations 6 days in advance).
- 5. All Members may receive 10% off merchandise items in the pro shop, unless stipulated otherwise. Membership discount not valid on food, beverage, special orders, services, and sales items.
- 6. Outside Food, Beverages, and Coolers are prohibited from being brought onto the golf course property.
- 7. Masters Week is the only time members are required to ride Prior to 4 p.m. The week will be determine yearly by management.

DATA REQUIRED BY THE PRIVACY ACT OF 1974, AUTHORITY: 10 USC 3012 PRINCIPAL PURPOSE: To insure eligibility of personnel using the facility and to maintain a record of membership participants in the special rates of the golf course.

#### Terms:

- 1. All Annual membership patrons must fill out a renewal agreement for each year.
- 2. Memberships may terminate privileges, without penalty, only with official PCS (Permanent Change of Station.) Requests for refunds must be accompanied with a copy of Change of Station Orders.
- 3. TDY Memberships are the only monthly payment option.
- 4. Annual rates are subject to change, with a 30-day notice and Garrison Commander's approval.
